Abstract of the address of Little Standing Buffalo or Yellow Buffalo,a Ponka Indian, made May 20,1889.

"Grandfather, I wish to tell you about something that I did not speak of the last time I daw you.

There is one Indian custom which I have been trying to break up, and I now ask your help in abolishing it. The Indians have their daughters marked with needles on their foreheads, chests, and backs, for which they have to pay a great deal, such as horses, blankets, hogs, fresh meat, etc. This tends to keep the Ponkas poor. The chiefs receive the pay, in return for which they authorize the "spotting," and it is to their interest to have the custom retained. The captain of the police took his three daughters from the school and had them tattooed, in spite of my efforts to prevent it. I appealed to the captain of the police, the agent, and the chiefs; but they did not help me. The only person who sided with me was the teacher(superin*formus Holmest*, *automated of the police und clust talling, paint the of the police* discharged, but he gave a horse to the interpreter, and that prevented it.

I also wish my friend here, one of your employees (Frank La Flesche), to come with the inspector as his interpreter, for we have no good interpreters. In this matter, I feel that the only interpreters to be had at the Agency, or on the reservation, will side with the chiefs, and so they will not interpret correctly."

I, the undersigned, certify on honor that I read the above abstract to Little Standing Buffalo or Yellow Buffalo, in his own language, and he accepted it as correct. I have reasons for believing what he says about the difficulty of obtaining a Ponka interpreter, having had some experience. Charles Le Clerc, my former interpreter is with the Dakotas; his brother, David, the former Agency interpreter, is (from what I have heard) infirm, probably bedridden, and unable to serve. Gen. Crook and Capt. John G. Bourke (3d. cavalry, now at the Library of the War Department) can tell you about the trouble in getting an interpreterin the winter of 1880-81.
